[Ethical review and approval]

Our research has received approval from the Ethics Committee of Kyoto University Graduate School and Faculty of Medicine, as well as the director-general of the Agency for Health, Safety and Environment, Kyoto University.

[Research aims and social contribution]

Our research aims are to evaluate the severity of mental illness in international university students and identify any potential risk factors. We will analyze this study and develop management strategies to detect and prevent mental illness in international university students at an early stage. We plan to use the findings of this study when allocating resources and personnel to support the increasing number of international university students.

[Purpose and method of information use]

The purpose of this study is to identify complex cases of mental illness among international students and to identify risk factors. The information collected will be strictly analyzed and stored within the Occupational Welfare Division, Agency for Health, Safety and Environment, Kyoto University. In this study, we will reanalyze the information obtained in the "Nationwide Descriptive Epidemiology Research and Multi-Center Case-Control Study of the Mental Health of International Students: For the Prevention of Progression of Illness Due to Difficulties in Assimilating into a Different Culture" (Kyoto University Ethics Committee approval number: R1237).
